**ORDER GRANTING MOTION FOR EXTENSION OF TIME**

Per Order dated June 14, 2011, the undersigned granted Respondent's Motion for Extension of Time filed June 10, 2011, and extended the deadline to July 18, 2011, for the filing of either Respondent's Prehearing Exchange or a fully-executed Consent Agreement and Final Order ("CAFO").

Per Order dated July 15, 2011, the undersigned granted the parties' Joint Motion for Extension of Time dated July 14, 2011, and extended the deadline to August 5, 2011, for the filing of either Respondent's Prehearing Exchange or a fully-executed CAFO.

On August 4, 2011, Respondent filed a third Motion for Extension of Time ("Motion"), wherein it requests an extension of the August 5, 2011, deadline by thirty days. The Motion states that Respondent "signed the consent decree" on July 25, 2011, and its finalization is "awaiting the signatures of the various parties representing Complainant." Respondent states that Complainant does not oppose the Motion and that the agreement "should be filed shortly."

The Rules of Practice governing this proceeding, 40 C.F.R. Part 22, provide at Rule 22.7 that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative." For good cause shown, Respondent's Motion for Extension of Time is **GRANTED**.

Because the consent decree has been signed by Respondent, Complainant shall file it as soon as it is fully executed, no later than **Tuesday, September 6, 2011**.
