Patrick Rankin, Regional Judicial Officer,

Mr. Kibler and I had the opportunity to discuss the possibility of a Joint Stipulation on the Penalty. Unfortunately his client is not interested in going down that path. As a result, the EPA intends to draft a Supplemental Motion for Accelerated Decision with regard to the penalty and to submit a couple of supplemental documents for your consideration.

I anticipate I can draft the motion and have it filed, along with any supporting documents, in three weeks time if that is acceptable to you. By my calculation, that would leave me until June 6th, 2012, to file the motion and supporting documents. I have spoken with Mr. Kibler and he indicated he had no objection to my proposed timeline.
