- Pursuant to the Report Recommending Termination of Alternative Dispute Resolution Process and Assignment of a Judge for Litigation (ADR Report), issued by Administrative Law Judge Barbara A. Gunning, on October 29, 2009, the ADR process terminated on October 24, 2009.
- 2. That the ADR process conducted by Judge Gunning was extremely beneficial, in that it helped the Parties make significant progress toward settlement in this matter.
- 3. That the Parties have continued to further their discussions in order to reach settlement in this matter, including Respondent's proposal to develop a Supplemental Environmental Project (SEP), which has been tentatively approved by EPA, pending only formal submittal of the SEP proposal and work plan.
- 4. That Respondent is continuing to make progress in its effort to develop the SEP proposal and work plan that needs to be submitted.

- That once the SEP proposal and work plan are submitted, the Parties will more than likely be able to execute the Consent Agreement and Final Order (CA/FO).
- 6. That the parties desire to continue their good faith efforts in negotiating this settlement before the liligation process is initiated.
- That the undersigned attorneys believe that a period of ninety (90) days will be adequate to allow the Parties to execute the CA/FO.

WHEREFORE, Complainant and Respondent jointly request a stay of the proceedings in this action for a period of ninety (90) days, in order to allow the Parties sufficient time execute the CA/FO.
