ORDER GRANTING MOTION AND AMENDING PREHEARING ORDER

A Prehearing Order was issued in this matter ordering the parties to engage in a settlement conference by May 20, 2011 and file a status report by May 27, 2011, ordering Complainant to file either a CAFO or its Initial Prehearing Exchange by June 17, 2011, ordering Respondent to file its Prehearing Exchange by July 8, 2011, and ordering Complainant to file its Rebuttal Prehearing Exchange by July 22, 2011.

On May 11, 2011, Complainant filed a Motion for Stay ("Motion"), seeking a stay of the prehearing deadlines for one month "[d]ue to an accident" necessitating Complainant's medical leave until "at least June 13, 2011." Complainant notes that Respondent does not oppose the Motion.

The unopposed Motion is hereby GRANTED for good cause in accordance with 40 C.F.R. § 22.7(b). Accordingly, the parties are directed to engage in a settlement conference on or before **June 24, 2011**. Complainant shall file a status report regarding settlement on or before **July 1, 2011**. If the case is settled, the fully-executed Consent Agreement and Final Order should be filed no later than **July 22, 2011**, with a copy sent to the undersigned.

Should a Consent Agreement not be finalized on or before the latter date, the parties must prepare for hearing and shall strictly comply with the prehearing requirements of the Prehearing Order issued May 4, 2011, in accordance with the revised deadlines set forth herein:

- July 22, 2011** Complainant's Initial Prehearing Exchange
- August 12, 2011** Respondent's Prehearing Exchange
- August 26, 2011** Complainant's Rebuttal Prehearing Exchange

**Additionally, the parties are hereby put on notice that pursuant to an agreement with Region IX, all documents and correspondence filed in this matter shall be filed with the Headquarters Hearing Clerk at the following postal address:**


