

MOTION FOR STAY OF PROCEEDINGS PENDING EXECUTION OF CONSENT AGREEMENT AND FINAL ORDER

Region 2 of the United States Environmental Protection Agency ("the Region") requests that the Regional Judicial Officer grant a 10-day stay of the proceedings in the above-captioned matter.

The parties have memorialized their agreement in a Consent Agreement and Final Order, which the Respondent has signed and forwarded to the undersigned. Region 2 is in the process of obtaining the necessary internal approval signatures, including signature of the Order by the Regional Administrator.

The undersigned has consulted the instant petition with counsel for Respondent, and counsel for Respondent has expressed agreement with the same.

For the reasons set forth above, EPA requests that the Regional Judicial Officer extend the deadline for the Respondent's response to June 12, 2009 without prejudice to Respondent's right to request re-activation of the proceedings if that should prove necessary.
