ORDER GRANTING MOTION FOR ABEYANCE OF CASE SCHEDULE

On February 9, 2011, the undersigned issued a Prehearing Order in this case. Pursuant to that Order, Complainant was required to file a Status Report on or before March 17, 2011, notifying the undersigned of the status of settlement negotiations.

On March 16, 2011, Complainant filed a Settlement Status Report and Motion for Abeyance of Case Schedule. Complainant relates that "[t]he parties have just reached [an] agreement in principle on the significant terms of settlement." In order to provide the parties an opportunity to record this agreement in a Consent Agreement and Final Order, which will include a Supplemental Environmental Project, Complainant requests that the undersigned hold the case schedule in abeyance for 90 days and allow the parties to report on the status of settlement at that time. Complainant represents that Respondent consents to the Motion.

For good cause shown, the Motion is GRANTED. Accordingly, this case shall be held in abeyance until June 1, 2011. On or before that date, Complainant shall file a status report regarding the status of settlement of this matter.
