Good Afternoon,

The United States Environmental Protection Agency (EPA) is issuing the attached Stop Sale, Use or Removal Order (SSURO or Order) to San-X, LLC (San-X) for the pesticide product, San-X Disinfectant Spray. This correspondence contains the Order and a Transmittal Letter for the Order.

This Stop Sale, Use or Removal Order is being issued based on information discovered through an inspection of San-X, LLC's compliance with the Federal Insecticide, Fungicide, and Rodenticide Act, and the federal regulations promulgated thereunder.

The SSURO directs San-X to immediately cease the sale, use or removal of the Product, unless written permission is provided by the EPA, and is ***effective immediately upon receipt***. This Order requires San-X to comply with the provisions set forth in the attached SSURO.

The EPA requests that *you immediately confirm receipt of this e-mail and the attached SSURO and transmittal letter*. Please reply to all.
