STATEMENT OF PURPOSE

1. This Addendum modifies the Administrative Order for Compliance on Consent (Consent Order) issued October 27, 2015, concerning the City of Bozeman, Montana (Respondent) and Respondent's approved pretreatment program implementation. The Respondent owns and operates a wastewater treatment plant (WWTP) located at 255 Moss Bridge Road in Bozeman, Montana. Specifically, this Addendum modifies the deadline in Paragraph 195 of the Consent Order. This will allow for additional sampling to be conducted during the spring and summer seasons to support the development of approvable local limits.

MODIFICATION

2. This Addendum hereby amends the first sentence of paragraph 195 of the Consent Order to read:

By August 31, 2016, the Respondent shall submit to the EPA an updated, approvable pretreatment ordinance and updated, approvable local limits.
3. The Respondent waives any and all remedies, claims for relief, and otherwise available rights to judicial or administrative review that the Respondent may have with respect to any issue of fact or law set forth in this Addendum, including any right of judicial review of this Addendum under the Administrative Procedure Act, 5 U.S.C. §§ 701-706. The Respondent further agrees not to


challenge the jurisdiction of the EPA in any proceeding to enforce this Addendum or in any action under this Addendum.

4. This Addendum shall be effective immediately upon the Respondent's receipt of a fully executed copy.


