

On June 21, 2013, counsel for the Complainant United States Environmental Protection Agency (EPA) notified Ms. Tina Artemis, Regional Hearing Clerk for EPA Region 8, by email that the EPA and Respondent Rick Smith had reached an agreement in principle to settle this matter. Therefore, the EPA respectfully requests that the deadline for the parties to provide information in response to the Regional Judicial Officer's Order for Production of Evidence and Clarification dated June 12, 2013 (the Order), be extended to Monday, August 12, 2013.

On June 21, 2013, counsel for the EPA mailed a consent agreement to the Respondent for his signature. The EPA anticipates that the Respondent will execute and return the consent agreement shortly, which will dispense with the need to respond to the Order.

A proposed order granting this request is being filed concurrently with this request.
