Dear Mr. Patch:

This letter is to inform you of the U.S. Environmental Protection Agency's decision to close the Findings of Violation and Order for Compliance (Order) issued to the Town of Brockton (Town) by the EPA on June 3, 2015. The EPA issued the Order to resolve violations of the Clean Water Act (CWA) and National Pollutant Discharge Elimination System (NPDES) permit at the Town's Wastewater Treatment Facility (Facility). The EPA has determined that the terms of the Order have been complied with since the Assiniboine and Sioux Tribes (Tribes) of the Fort Peck Reservation retained a wastewater operator to perform regular operation and maintenance at the Facility and submit monthly discharge monitoring reports.

It is the EPA's understanding that as of November 2, 2016, due to the Town's de facto bankruptcy status, Roosevelt County (County) is working with the Tribes to allow the Tribes use of the Town's wastewater equipment; ensure timely and complete payment of the Facility's electricity bills; and maintain compliance with the CWA and the NPDES permit requirements at the Facility. The EPA further understands that the County ultimately will transfer the Town's wastewater and solid waste assets to the Tribes for the Tribes to perform these services without interruption. In the event that any of these plans change, please notify my staff identified below.

Please be aware that until the Town transfers its ownership interest in the Facility to the Tribes and terminates the Facility's NPDES permit as to the Town's status as a permittee, the Town is responsible for complying with the CWA and the NPDES permit requirements pursuant to section 402 of the CWA, 33 U.S.C. § 1342. Violations of the CWA and/or permit may result in a court-imposed injunction and/or penalties.
