

COMES NOW, Complainant, the United States Environmental Protection Agency (EPA) Region 4, and files this Status Report to inform the Court that Complainant and Respondent have reached an Agreement in Principle to settle, for a fixed amount, the above-captioned matter. EPA is currently drafting a Consent Agreement and Final Order (CAFO), which it expects to mail and send via facsimile to Respondent by no later than October 4, 2010. The CAFO will ask that Respondent execute the document and mail it back to EPA by no later than October 18, 2010. Once EPA receives the CAFO the document will have to be routed internally for EPA's signature. EPA expects to have a fully executed document by October 29, 2010.


