COME NOW Respondents BOSFuel Corporation ("BOSFuel") and Swissport Fueling, Inc. ("Swissport") (collectively, "Respondents"), and respectfully apply to Regional Judicial Officer Jill Metcalf for an extension of time to Answer the Administrative Complaint in this matter until January 20, 2012.

In support of its Request, Respondents state as follows:

1. Respondents' first request for extension of time until December 2, 2011 was granted by the Regional Judicial Officer on October 20, 2011. The initial request for an extension of time was in-part for the purpose of scheduling a meeting among all interested parties to discuss the issues raised in the Administrative Complaint.

2. Scheduling the meeting required coordination among a large number of agency personnel and Respondents. Agency attendees will include representatives of EPA, the U.S. Coast Guard, Massachusetts Department of Environmental Protection, and Massport.

3. Despite best efforts otherwise, the scheduling conflicts of all parties resulted in December 1, 2011 as the first available meeting date to discuss the facts of the matter and possible resolution of the issued raised.



Due to business travel, the upcoming holiday season and vacation schedules of the parties subsequent to the December 1, 2011 meeting, extending the deadline to answer the Administrative Complaint until January 20, 2012 will allow the parties sufficient time to engage in meaningful settlement discussions after attending the December 1st meeting.

5. Senior Enforcement Counsel for the U.S. Environmental Protection Agency – Region I, Tonia Bandrowicz, Esq. has been contacted and has agreed to this requested extension.

6. This requested extension of time is made for good cause and not for purpose of delay.


