1. Pursuant to this Honorable Court's Order on Joint Motion for Continuance, dated December 1, 2009, Complainant in the above-captioned matter was directed to file a Status Report on the progress of settlement on December 18, 2009.

2. That on Thursday, December 10, 2009, the undersigned, along with Mr. José A. Rivera and Ms. Yolianne Maclay, EPA's Multimedia Permits and Compliance Branch Enforcement Officers assigned to this matter, met with Nancy Soto, Esq., Respondent's Counsel, and Mr. Felipe de Jesus, Respondent's Environmental Consultant, with the purpose of visiting proposed Supplemental Environmental Project's (SEP) site.

3. That although the proposed SEP, as presented, did not comply with EPA's SEP Policy, Mr. Rivera and Ms. Maclay provided some guidance on some changes that could be made to the proposed SEP to comply with EPA's SEP Policy.

4. That Complainant advised Respondent that even if the suggestions were taken into account, the proposed SEP's environmental benefit may not amount to a substantial monetary reduction to the proposed penalty.

5. That Complainant advised Respondent to consider proposing a different SEP and/or consider negotiating the monetary portion alone. Mr. Rivera and Ms. Maclay provided some guidance on what other SEPs Respondent could consider proposing.

6. That Respondent suggested it intends on proposing a different SEP within the next week.

WHEREFORE it is respectfully requested that the Court take notice of the status of the foregoing progress of settlement.
