

NOTICE TO WITHDRAW COMPLAINT

NOW COMES Complainant, the Director of the Compliance Assurance and Enforcement Division, United States Environmental Protection Agency, Region 6, through his attorney, and pursuant to 40 C.F.R. § 22.14(d) respectfully states as follows:

- I. This proceeding for the assessment of a civil penalty was instituted pursuant to Section 1414(g)(3) of the Safe Drinking Water Act (herein "the Act"), 42 U.S.C. § 300g-3(g)(3) by the issuance of a Complaint, Compliance Order and Notice of Opportunity for Hearing ("Complaint") on January 21, 2009.
- 2. The Complaint was served upon Kent Hamilton d/b/a Sleepy Hollow Mobile Home Park located in Ada, Oklahoma (hereinafter the "Respondent") by the Complainant, the Director of the Complainance Assistance and Enforcement Division, United States Environmental Protection Agency, Region 6 (hereinafter the "Complainant" or "EPAn).
 - 3. Respondent has filed its Answer and Request for Hearing on December II, 2008.
- 4. Under 40 C.F.R. § 22.14(d), after the filing of an answer, the Complainant may withdraw the Complaint without prejudice one time before the answer has been filed.
- 5. The Respondent has hired a new contractor to run the public water system and is currently in compliance.

6. No party will be prejudiced by the filing of this Notice to Withdraw the Complaint.

THEREFORE, in the interests of justice and pursuant to 40 C.F.R. § 22.14(d), Complainant requests that the Court grant Complainant's Notice to Withdraw the Complaint without prejudice.
