CONSENT AGREEMENT

I. STATUTORY AUTHORITY

1.1. This Consent Agreement is issued under the authority vested in the Administrator of the U.S. Environmental Protection Agency ("EPA") by Section 113(d) of the Clean Air Act ("CAA"), 42 U.S.C. § 7413(d).

1.2. Pursuant to Section 113(d) of the CAA, 42 U.S.C. § 7413(d), and in accordance with the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties," 40 C.F.R. Part 22, EPA issues, and Waupaca Northwoods, LLC ("Respondent") agrees to issuance of, the Final Order attached to this Consent Agreement ("Final Order").

II. PRELIMINARY STATEMENT

2.1. In accordance with 40 C.F.R. §§ 22.13(b) and 22.18(b), issuance of this Consent Agreement commences this proceeding, which will conclude when the Final Order becomes effective.

2.2. The Director of the Office of Compliance and Enforcement, EPA Region 10
("Complainant") has been delegated the authority pursuant to Section 113(d) of the CAA,
42 U.S.C. § 7413(d), to sign consent agreements between EPA and the party against whom an administrative penalty for violations of the CAA is proposed to be assessed.

2.3. Part III of this Consent Agreement contains a concise statement of the factual and legal basis for the alleged violations of the CAA together with the specific provisions of the CAA and the implementing regulations that Respondent is alleged to have violated.

III. <u>ALLEGATIONS</u>

3.1. Pursuant to Section 301(a) and 301(d)(4) of the CAA, 42 U.S.C. § 7601(a) and 7601(d)(4), EPA has adopted air quality regulations that apply to air pollution sources on Indian Reservations in Idaho, Oregon, and Washington, which are codified at 40 C.F.R. Part 49, Subparts C and M. These rules are known as the Federal Air Rules for Reservations ("FARR") and became effective on June 7, 2005.

3.2. The FARR provisions that apply within the Yakama Reservation are incorporated by reference at 40 C.F.R. § 49.11110(a)-(k).

3.3. 40 C.F.R. § 49.138, the rule for registration of air pollution sources and the reporting of emissions, incorporated by reference at 40 C.F.R. § 49.11110(j), applies to any person who owns or operates a part 71 source or an air pollution source that is subject to a

standard established under Section 111 or 112 of the CAA, and any person who owns or operates any other air pollution source that is not exempted.

3.4. 40 C.F.R. § 49.138(c), incorporated by reference at 40 C.F.R. § 11110(j), exempts, *inter alia*, air pollution sources that do not have the potential to emit more than two tons per year of any air pollutant.

3.5. 40 C.F.R. § 49.138(d), incorporated by reference at 40 C.F.R. § 11110(j), requires a person who owns or operates an air pollution source subject to the requirement to register the air pollution source annually with the EPA Regional Administrator by February 15 of each year.

3.6. 40 C.F.R. § 49.123(a), incorporated by reference at 40 C.F.R. § 11110(a), defines owner or operator as any person who owns, leases, operates, controls, or supervises an air pollution source.

3.7. 40 C.F.R. § 49.123(a), incorporated by reference at 40 C.F.R. § 11110(a), defines air pollution source as any building, structure, facility, installation, activity, or equipment, or combination of these that emits, or may emit, an air pollutant.

3.8. 40 C.F.R. § 49.123(a), incorporated by reference at 40 C.F.R. § 11110(a), defines air pollutant as any air pollution agent or combination of such agents, including any physical, chemical, biological, radioactive substance or matter that is emitted into or otherwise enters the ambient air.

3.9. Respondent is a corporation, registered in the State of Washington, and is a person as defined in CAA § 302(e), 42 U.S.C. § 7602(e).

3.10. Respondent owns a facility located at 81 North Track Road, Parker, Washington, that emits an estimated 9.7 tons of particulate matter and 2.6 tons of particulate matter less than 10 microns in size per year.

3.11. Respondent is a person who owns an air pollution source with the potential to emit more than two tons per year of any air pollutant and therefore is not exempt from 40 C.F.R. § 49.138, incorporated by reference at 40 C.F.R. § 11110(j).

3.12. Respondent submitted the annual registration for the air pollution source it owns to the EPA Regional Administrator on April 23, 2014.

3.13. Respondent failed to timely submit the annual registration for its air pollution source, in violation of 40 C.F.R. § 49.138, incorporated by reference at 40 C.F.R. § 11110(j).

3.14. Under Section 113(d) of the CAA, 42 U.S.C. § 7413(d), and 40 C.F.R. Part 19, EPA may assess a civil penalty of not more than \$37,500 per violation per day.

IV. TERMS OF SETTLEMENT

4.1. Respondent admits the jurisdictional allegations of this Consent Agreement.

4.2. Respondent neither admits nor denies the specific factual allegations contained in this Consent Agreement.

4.3. As required by Section 113(e)(1) of the CAA, 42 U.S.C. § 7413(e)(1), EPA has taken into account the size of the business, the economic impact of the penalty on the business, Respondent's full compliance history and good faith efforts to comply, the duration of the violation as established by any credible evidence, payment by Respondent of penalties previously assessed for the same violation, the economic benefit of noncompliance, the seriousness of the violation, and such other factors as justice may require. After considering these factors, EPA has determined and Respondent agrees that an appropriate penalty to settle this action is \$304.

4.4. Respondent agrees to pay the total civil penalty set forth in Paragraph 4.3 within30 days of the effective date of the Final Order.

4.6. Concurrently with payment, Respondent must serve photocopies of the check, or proof of other payment method, described in Paragraph 4.5 on the Regional Hearing Clerk and EPA Region 10 at the following addresses:

4.7. If Respondent fails to pay any portion of the penalty assessed by this Consent

Agreement and the Final Order in full by its due date, the entire unpaid balance of penalty and

accrued interest shall become immediately due and owing. If such a failure to pay occurs,

Respondent may be subject to a civil action pursuant to Section 113(d)(5) of the CAA, 42 U.S.C.

§ 7413(d)(5), to collect the assessed penalty under the CAA. In any collection action, the

validity, amount, and appropriateness of the penalty shall not be subject to review.

4.8. If Respondent fails to pay any portion of the penalty assessed by this Consent Agreement and the Final Order in full by its due date, Respondent shall be responsible for payment of the following amounts:

4.8.1. Interest. Any unpaid portion of the assessed penalty shall bear interest at the rate established pursuant to 26 U.S.C. § 6621(a)(2) from the effective date of the Final Order, provided, however, that no interest shall be payable on any portion of the assessed penalty that is paid within 30 days of the effective date of the Final Order contained herein.

4.8.2. Attorneys Fees, Collection Costs, Nonpayment Penalty. Pursuant to 42 U.S.C. § 7413(d)(5), should Respondent fail to pay the assessed penalty and interest on a timely basis, Respondent shall also be required to pay the United States' enforcement expenses, including but not limited to attorneys fees and costs incurred by the United States for collection proceedings, and a quarterly nonpayment penalty for each quarter during which such failure to pay persists. Such nonpayment penalty shall be ten percent of the aggregate amount of Respondent's outstanding penalties and nonpayment penalties accrued from the beginning of such quarter.

4.9. The penalty described in Paragraph 4.3, including any additional costs incurred under Paragraph 4.8, represents an administrative civil penalty assessed by EPA and shall not be deductible for purposes of federal taxes.

4.10. The undersigned representative of Respondent certifies that he or she is authorized to enter into the terms and conditions of this Consent Agreement and to bind Respondent to this document.

4.11. The undersigned representative of Respondent also certifies that, as of the date of Respondent's signature of this Consent Agreement, Respondent has corrected the violation(s) alleged in Part III.

4.12. Except as described in Paragraph 4.8, each party shall bear its own costs and attorneys fees in bringing or defending this action.

4.13. Respondent expressly waives any right to contest the allegations contained in this Consent Agreement and to appeal the Final Order.

4.14. The provisions of this Consent Agreement and the Final Order shall bind Respondent and its agents, servants, employees, successors, and assigns.

4.15. Respondent consents to the issuance of any specified compliance or corrective action order, and to any stated permit action.
