

**DECLARATION OF MARK C. KELLY**

MARK C. KELLY, hereby declares, pursuant to 28 U.S.C. Sec. 1746 that the following statements are true and correct, under penalty of perjury:

1. My name is Mark C. Kelly and I am over 18 years of age. I make this declaration voluntarily and based upon my own personal knowledge. I am an attorney admitted in New York and I am counsel for respondent, Cycle Chem, Inc. I have personal knowledge of the facts which follow. This declaration is submitted in support of the within motion for an extension of time, pursuant to 40 C.F.R. 22.7(b), to file Respondent's Prehearing Exchange from November 28, 2011 to December 8, 2011.

2. This proceeding was commenced with the filing of a Complaint on June 29, 2011 and an Answer was filed with the time allowed by the Consolidated Rules of Practice.

3. Pursuant to Prehearing Order entered herein on August 26, 2011, Complainant's Prehearing Exchange was due on October 28, 2011, and Respondent's Prehearing Exchange is due November 28, 2011 and Complainant's Rebuttal Prehearing Exchange is currently due on December 12, 2011.

4. The undersigned had eye surgery on Monday November 14, 2011. As a result, the undersigned received an extension for a reply brief due in the Appellate Division Second Department, New York from November 17, 2011 to November 28, 2011 and no further extension is permitted absent hardship.

5. Respondent Cycle Chem, Inc. is closed on Thursday November 24 and Friday November 25, 2011 due to the Thanksgiving Holiday. The undersigned needs to consult with the Regulatory manager to obtain information and documentary proof, which is informed by research currently ongoing.

6. The undersigned has obligations for family events being hosted at his domicile on November 24, 2011.
