Dear Mr. Mackay:

On August 31, 2017, the U.S. Environmental Protection Agency issued an Administrative Order (Order), Docket No. SDWA-08-2017-0030, directing Fireside Resort Inc. and Mackay Investments, LLC (the Companies), referenced in the Order as the Respondents, as owners/operators of the Jackson Hole Campground public water system, to comply with various drinking water regulations issued by the EPA under the Safe Drinking Water Act (SDWA), 42 U.S.C. section 300f et seq.

Our records indicate that the Companies, are in violation of the Order. Among other things, the Order included the following requirement (quoted from item 8 on page 1 of the Order), which has not been fulfilled:

- Within 30 of days of receipt of this Order, and as required by the Drinking Water Regulations thereafter, Respondent shall monitor the System's water for nitrate.

The EPA received nitrate samples for 2017, however the samples were not collected at the required location. The 2017 samples cannot be accepted for compliance. Additionally, the EPA has not received nitrate samples for 2018 or 2019.


**The EPA is considering additional enforcement action as a result of non-compliance with the Order.** Violating the Order may lead to (1) a penalty of up to \$58,328 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
