As requested during our ADR meeting dated August 14, 2016, Complainant is submitting a status report regarding settlement in this matter.

EPA and Tesoro Refining and Marketing Company, LLC (Tesoro) have reached settlement in this matter. On August 26, 2016, EPA sent a Consent Agreement and Final Order (CAFO) to Tesoro for final review and signature. Upon receipt of the signed CAFO, EPA will sign the Agreement after which it will be presented to the Regional Judicial Officer for review and approval. The original will be filed with the EPA Region 10 Hearing Clerk.

The Parties do not anticipate any problem of having a signed CAFO by the October 3, 2016, ADR deadline.


