Dear Mr. Wasserman:

The purpose of this letter is to inform you that the U.S. Environmental Protection Agency (EPA) is terminating the Consent Agreement and Final Order (CAFO), Docket Number RCRA-04-2014-4012(b), entered into between the EPA and Camino Reale Properties, LLC (Camino), and filed with the Regional Hearing Clerk on September 18, 2014. The CAFO was entered into pursuant to Section 3008(a) of the Resource Conservation and Recovery Act (RCRA), as amended, 42 U.S.C. § 6928(a), and relates to Camino's facility located at 8600 Bunkhouse Road, Orlando, Florida 32832 (the Facility). The CAFO required Camino to conduct assessment and remediation activities at the Facility to address potential contamination from the prior use of the Facility as a recreational shotgun range.

Upon receipt of the Acknowledgment, the EPA will execute the document and send a copy to Camino. This CAFO termination will not be effective until the Acknowledgment is executed by both parties.

Please note that termination of the CAFO shall not terminate Camino's obligations to comply with any continuing obligations of the CAFO, including, but not limited to, Section XVIII (Record Preservation), Section XXII (Reservation of Rights), Section XXIV (Other Applicable Laws), and Section XXIII (Other Claims). Termination of the CAFO does not impact any remaining work or activities at the Facility that may be required by other orders or actions, including, but not limited to, any future actions that may be required by the Florida Department of Environmental Protection.
