ORDER TO RESPONDENT TO SHOW CAUSE

Background

Pursuant to the Consolidated Rules of Practice, 40 C.F.R. Part 22, Complainant filed an Administrative Complaint, Compliance Order and Notice of Opportunity for Hearing ("complaint") in this proceeding on April 2, 2010, alleging violations of provisions of the Solid Waste Disposal Act, 42 U.S.C. § 6901, et seq., which the record indicates was served on Respondent on April 21, 2010. Pursuant to Rule 15(a), 40 C.F.R. § 22.15(a), any answer to the complaint was required to be filed within 30 days thereafter. On May 27, 2011, Complainant filed and served a Motion for Default Order as to Liability and Penalty ("motion"). The record in this proceeding does not indicate that Respondent filed any answer to the 2010 complaint, or any response to the 2011 motion. Rule 22.17(a), 40 C.F.R. § 22.17(a), provides, in part, that a party may be found in default, upon motion, for failure to file an answer to a complaint. Rule 22.17(c), 40 C.F.R. § 22.17(c), provides, in part, that the relief requested in a complaint or motion for default order may be ordered against a defaulting party, if appropriate. The relief

requested in this proceeding includes a request for the assessment of a civil penalty in the amount of \$141,360.

Respondent is hereby ordered to show cause, if any exists, why it should not be found in default in this proceeding and assessed a penalty, as set forth above. Respondent shall file any response to this order no later than January 23, 2012.
