This a second Addendum to the Administrative Order (Order) issued on December 28, 2017, to Potlatch Trailer Court. Respondent must achieve and maintain compliance with the nitrate MCL by the final date specified in the approved schedule. The EPA is authorized to seek penalties if these deadlines are not met. If Potlatch Trailer Court has a reasonable basis to believe it may be unable to meet any deadline in the schedule, it shall notify the EPA well in advance of the scheduled deadline to request an extension. The EPA may, in its discretion, consider granting an extension. As a reminder, you are required to provide the EPA with quarterly progress reports.
