I. STATUTORY AUTHORITY

- I.1. This Consent Agreement and Final Order ("CAFO") is issued under the authority vested in the Administrator of the U.S. Environmental Protection Agency ("EPA") by Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act ("FIFRA"), 7 U.S.C. § 136l(a).
- 1.2. The Administrator has delegated the authority to issue the Final Order contained in Part V of this CAFO to the Regional Administrator of EPA Region 10, who has redelegated this authority to the Regional Judicial Officer in EPA Region 10.
- 1.3. Pursuant to Section 14(a) of FIFRA, 7 U.S.C. § 136*l*(a), and in accordance with the "Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties," 40 C.F.R. Part 22, EPA issues, and Syngenta Crop Protection, LLC ("Respondent") agrees to issuance of, the Final Order contained in Part V of this CAFO.

II. PRELIMINARY STATEMENT

- 2.1. In accordance with 40 C.F.R. §§ 22.13(b) and 22.18(b), issuance of this CAFO commences this proceeding, which will conclude when the Final Order contained in Part V of this CAFO becomes effective.
- 2.2. The Director of the Office of Compliance and Enforcement, EPA Region 10 ("Complainant") has been delegated the authority pursuant to Section 14(a) of FIFRA, 7 U.S.C. § 136l(a), to sign consent agreements between EPA and the party against whom an administrative penalty for violations of FIFRA is proposed to be assessed.
- 2.3. Part III of this CAFO contains a concise statement of the factual and legal basis for the alleged violations of FIFRA together with the specific provisions of FIFRA and the implementing regulations that Respondent is alleged to have violated.

III. ALLEGATIONS

- 3.1. Under Section 2(s) of FIFRA, 7 U.S.C. § 136(s), the term "person" means "any individual, partnership, association, corporation, or any organized group of persons whether incorporated or not."
- 3.2. Under Section 2(gg) of FIFRA, 7 U.S.C. § 136(gg), the term "distribute or sell" means "distribute, sell, offer for sale, hold for distribution, hold for sale, hold for shipment, ship, deliver for shipment, release for shipment, or receive and (having so received) deliver or offer to deliver."
- 3.3. Under Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E), it is unlawful for any person to distribute or sell to any person any pesticide which is misbranded.

- 3.4. Under 40 C.F.R. § 165.67(c), the registrant of a pesticide may be held liable for violations relating to a repackaged pesticide product.
 - 3.5. Respondent is a "person" as defined by FIFRA Section 2(s), 7 U.S.C. § 136(s).
 - Respondent is the registrant of Quilt Xcel Fungicide (EPA Reg. No. 100-1324).
- 3.7. Crop Production Services, Inc. ("CPS") owns and operates a business facility ("facility") located at 32092 Old Highway 34 East in Tangent, Oregon.
- 3.8. At the time of the alleged violations, CPS repackaged Quilt Xcel Fungicide for distribution or sale at the facility under an agreement with Respondent.
- 3.9. At the time of the alleged violations, Respondent provided CPS with labels for repackaging Quilt Xcel Fungicide.
- 3.10. On at least six occasions in 2012, CPS repackaged Quilt Xcel Fungicide for distribution or sale in refillable containers that did not bear the label required by 40 C.F.R. § 156.140 and therefore were misbranded.
- 3.11. On at least one occasion in 2012, Respondent distributed or sold Quilt Xcel Fungicide to CPS in a refillable bulk pesticide storage tank that did not bear the label required by 40 C.F.R. § 156.140 and therefore was misbranded.
- 3.12. Respondent violated Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E), by distributing or selling mislabeled pesticides.
- 3.13. Pursuant to FIFRA Section 14(a)(1), 7 U.S.C. § 136l(a), and 40 C.F.R. Part 19, EPA may assess a civil penalty of not more than \$7,500 for each offense against any registrant, commercial applicator, wholesaler, dealer, retailer, or other distributor who violates any provision of Section 12 of FIFRA.

IV. CONSENT AGREEMENT

- 4.1. Respondent admits the jurisdictional allegations of this CAFO.
- 4.2. Respondent neither admits nor denies the specific factual allegations contained in this CAFO.
- 4.3. Respondent agrees that this settlement will be considered prior history of noncompliance under FIFRA for five years following the date of this CAFO for purposes of calculating penalty amounts in future EPA enforcement actions.
- 4.4. EPA has determined and Respondent agrees that an appropriate penalty to settle this action is \$50,100.
- 4.5. Respondent agrees to pay the total civil penalty set forth in Paragraph 4.4 within 30 days of the effective date of the Final Order contained in Part V of this CAFO.
- 4.6. Payment under this CAFO may be paid by check (mail or overnight delivery), wire transfer, ACH, or online payment. Payment instructions are available at:

- 4.8. If Respondent fails to pay the penalty assessed by this CAFO in full by its due date, the entire unpaid balance of penalty and accrued interest shall become immediately due and owing. Such failure may also subject Respondent to a civil action to collect any unpaid penalty under Section 14(a)(5) of FIFRA, 7 U.S.C. § 136l(a)(5), together with interest, handling charges, and nonpayment penalties described below.
- 4.9. If Respondent fails to pay any portion of the penalty assessed by this CAFO in full by its due date, Respondent shall also be responsible for payment of the following amounts:
 - 4.9.1. Interest. Any unpaid portion of the assessed penalty shall bear interest at the rate established by the Secretary of the Treasury pursuant to 31 U.S.C. § 3717(a)(1) from the effective date of the Final Order contained herein, provided, however, that no interest shall be payable on any portion of the assessed penalty that is paid within 30 days of the effective date of the Final Order contained herein.
 - 4.9.2. Handling Charge. Pursuant to 31 U.S.C. § 3717(e)(1), a monthly handling charge of \$15 shall be paid if any portion of the assessed penalty is more than 30 days past due.
 - 4.9.3. Nonpayment Penalty. Pursuant to 31 U.S.C. § 3717(e)(2), a nonpayment penalty of 6% per annum shall be paid on portion of the assessed penalty that is more

than 90 days past due, which nonpayment shall be calculated as of the date the underlying

penalty first becomes past due.

4.10. The penalty described in Paragraph 4.4, including any additional costs incurred

under Paragraph 4.9, above, represents an administrative civil penalty assessed by EPA and shall

not be deductible for purposes of federal taxes.

4.11. The undersigned representative of Respondent certifies that he or she is

authorized to enter into the terms and conditions of this CAFO and to bind Respondent to this

document.

4.12. The undersigned representative of Respondent also certifies that, as of the date of

Respondent's signature of this CAFO, Respondent has corrected the violation(s) alleged in

Part III above.

4.13. Each party shall bear its own costs and attorneys fees in bringing or defending this

action.

4.14. Respondent expressly waives any right to contest the allegations and waives any

right to appeal the Final Order set forth in Part V.

The provisions of this CAFO shall bind Respondent and its agents, servants,

employees, successors, and assigns.

4.16. The above provisions are STIPULATED AND AGREED upon by Respondent

and EPA Region 10.

In accordance with 40 C.F.R. § 22.31(a), nothing in this CAFO shall affect the right of EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law. This CAFO does not waive, extinguish, or otherwise affect Respondent's obligations to comply with all applicable provisions of FIFRA and regulations promulgated or permits issued thereunder.
 - 5.3. This Final Order shall become effective upon filing.
