Extension Request – Preventive Maintenance Plan

Dear Mr. Still,

Pursuant to Paragraph 52 of the Administrative Order on Consent (“AOC”), dated January 4, 2022, Hanover Foods Corporation (“HFC”) was required to submit to the United States Environmental Protection Agency, Region III (“EPA”) a Preventive Maintenance Plan (“PMP”) on or before July 3, 2022. By letter, dated June 30, 2022, HFC requested a 90-day extension for the submittal of the PMP. Pursuant to Paragraph 59 of the AOC, EPA is granting this 90-day extension, thus changing the required submittal date from July 3, 2022, to October 1, 2022.

Pursuant to Paragraphs 52 and 53 of the AOC, HFC is now required to submit to EPA a Preventive Maintenance Plan for review and approval no later than October 1, 2022.
