Dear Ms. Harrison:

On April 3, 2008, the U.S. Environmental Protection Agency (EPA) issued an administrative penalty complaint against Lincoln Road RV Park, Inc. (Lincoln Road) under section 1414 of the Safe Drinking Water Act (SDWA), 42 U.S.C. §300g-3. The complaint proposed that EPA assess a penalty of \$3,000.00 against Lincoln Road, due to Lincoln Road's failure to comply with a previously issued administrative order. The complaint and the accompanying cover letter explained a procedure for Lincoln Road to file an answer to contest the penalty. The answer was to have been filed within thirty days of your receipt of the complaint.

Although EPA received a return receipt card on April 10, 2008, indicating that you received the complaint, EPA has no record of having received an answer. Therefore, EPA would be entitled to file a motion for default asking the Regional Judicial Officer to assess the entire \$3,000.00. However, our office will hold off on filing such a motion if Lincoln Road files an answer by September 15, 2008.
