ORDER GRANTING JOINT MOTION FOR EXTENSION OF TIME

Per Order dated June 14, 2011, the undersigned granted Respondent's Motion for Extension of Time and extended the deadline to July 18, 2011, for the filing of either Respondent's Prehearing Exchange or a fully-executed Consent Agreement and Final Order.

The parties filed a Joint Motion for Extension of Time dated July 14, 2011, wherein they request a 15-day extension of time for Respondent to file its Prehearing Exchange. The Motion states, as good cause, that the parties are working with the State of Michigan, a third party to the proposed consent decree, to finalize signatures to the agreement, and believe that final settlement will be obtained "imminently."

The Rules of Practice governing this proceeding, 40 C.F.R. Part 22, provide at Rule 22.7 that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative." For good cause shown, the Joint Motion for Extension of Time is hereby **GRANTED**.

Respondent shall file either a fully-executed Consent Agreement and Final Order, or its Prehearing Exchange, by **August 5, 2011**.

If no Consent Agreement and Final Order has been filed beforehand, Complainant shall file its Rebuttal Prehearing Exchange by **August 19, 2011**.
