
**ORDER GRANTING RESPONDENT'S MOTION TO EXTEND DEADLINE TO
ANSWER COMPLAINT BY AGREEMENT OF THE PARTIES**

Respondent Allegan Metal Finishing Company (AMF) has filed a motion to extend the deadline to answer to Complaint through July 31, 2015. AMF asserts that it filed the motion by agreement of the parties. Complainant has not filed a response. This is AMF's third request for an extension of time to answer. The motion briefly summarizes the state of company's affairs following the March 15, 2015, fire that destroyed AMF's facility and its business records. Pursuant to the previous Order, the due date for the answer was June 29, 2015.

Pursuant to 40 C.F.R. § 22.7(b) and for good cause shown, AMF's motion for extension of time to file an answer is GRANTED. AMF will have until and including July 31, 2015, in which to file its answer to the Complaint or otherwise plead.
