ORDER ON RESPONDENT CAMEEL HALIM'S MOTION TO WITHDRAW PENDING MOTION TO DISMISS FOR WANT OF SUBJECT-MATTER JURISDICTION


On January 23, 2012, Respondent Cameel Halim ("Respondent Halim") submitted a Motion to Dismiss Respondent Cameel Halim for Want of Subject-Matter Jurisdiction. On February 7, 2012, Complainant filed a Response to Respondent's Motion to Dismiss Respondent Cameel Halim for Want of Subject-Matter Jurisdiction. Respondents assert that on February 16, 2012, they sent a Motion for Extension of Time to File Reply in Opposition to Complainant's Response to Respondent Cameel Halim's Motion to Dismiss for Want of Subject-Matter Jurisdiction via FedEx Overnight commercial delivery. The Motion for Extension requested a seven-day extension of the deadline to file a reply brief. The record indicates that this Motion for Extension was filed by the Regional Hearing Clerk on February 21, 2012. The undersigned subsequently received the Motion for Extension on February 28, 2012, a full 10 days after the original deadline for the reply brief.

On February 29, 2012, the undersigned received a Motion to Withdraw Respondent Cameel Halim's Motion to Dismiss for Want of Subject-Matter Jurisdiction ("Motion"). The

Motion indicates that the parties are involved in ongoing and fruitful settlement discussions and requests permission to withdraw the Motion, without prejudice, in order to focus efforts on those settlement discussions. For good cause shown, the Motion is **GRANTED**. The Motion to Dismiss is withdrawn and the Motion for Extension is disregarded as moot.

The parties are reminded to submit a Joint Status Report on or before **March 19, 2012**, stating whether a settlement has been reached. A prehearing order in this matter may be issued at that time.
