Muskegon Development Corporation, Mount Pleasant, Michigan Case Docket No. **SDWA-05-2012-0001**

The U.S. Environmental Protection Agency (U.S. EPA), Region 5, is providing this notice of its intent to file a proposed Consent Agreement and Final Order (CAFO) against the Muskegon Development Corporation (Respondent) for violations the Safe Drinking Water Act (SDWA). This proposed CAFO will settle civil violations alleging that the Respondent converted four oil production wells in Michigan into Class 2 Underground Injection Control (UIC) wells before the required Federal UIC permits were issued. The U.S. EPA and Respondent have agreed in principle that Respondent will pay a civil penalty of \$16,000.

OPPORTUNITY FOR COMMENT: Section 1423(c) of the SDWA, 42 U.S.C. §300h-2(c), requires that interested persons be given notice of the proposed penalty and a reasonable opportunity to comment on it.

Any person who wishes to comment on this CAFO may submit written comments, may attend or present evidence at any hearing scheduled on this matter, or both, by following the procedures in Title 40 of the Code of Federal Regulations, Part 22, Section 45 in particular 40 C.F.R. 22.45©, *Comment by a person who is not a party.* This portion of the Code of Federal regulations may be accessed at http://www.gpoaccess.gov/cfr/retrieve.html. All documents filed in this proceeding (including documents submitted by the Respondent or by public commenters) are available for public inspection by appointment only between 9 a.m. and 4:30 p.m. Monday through Friday at the U.S. EPA Region 5 Office. An appointment for such an inspection may be made by calling (312) 886-3713 or by writing the Regional Hearing Clerk at the address above. Copies of the Consent Agreement and Final Order are also available for viewing at the Alice & Jack Wirt Public Library, 500 Center Avenue, Bay City, Michigan 48708.

If this proposed CAFO is filed in its present form, no hearing will be held in this matter. If a hearing is held, we will provide notice of the date, time, and place of the hearing to all commenters who (during the public comment period) submitted a written request to participate in hearing, which they may attend and present evidence on the appropriateness of the proposed penalty assessment by following the instructions in 40 C.F.R. 22.45(c)(1).

The U.S. EPA will send a copy of the filed Consent Agreement and Final Order resolving this matter to any persons who submitted written comments or attended a hearing, provided they give us their current mailing address.

Only persons who submit written comments or ask to participate in any hearing held in this matter during this comment period preserve a right to petition the Regional Administrator to set aside the Consent Agreement and Final Order on the basis that material evidence was not considered, as described in 40 C.F.R. 22.45(c)(4).
