FOR WANT OF SUBJECT-MATTER JURISDICTION


Respondent Cameel Halim, through his undersigned counsel, hereby requests that he be allowed to withdraw, without prejudice, his previously filed Motion to Dismiss for Want of Subject-Matter Jurisdiction. In support of his Motion, Respondent Cameel Halim ("Halim") states as follows:

1. On or about January 23, 2012, the undersigned counsel filed Respondent Cameel Halim's Motion to Dismiss for Want of Subject-Matter Jurisdiction.
2. The undersigned attorney received EPA's Response on February 8, 2012.

3. On February 16, 2012 Halim, through the undersigned counsel, filed his Motion to Extend Time Within Which to File a Reply Memorandum.
4. On February 22, 2012, the undersigned counsel, Respondent Halim, Mary McAuliffe, counsel for EPA Region 5, and counsel for the United States Department of Housing and Urban Development (the "Parties") began telephonic settlement discussions with the Honorable J. Jeremiah Mahoney, Chief Administrative Law Judge for the United States Department of Housing and Urban Development. The settlement discussion lasted approximately two hours and was fruitful.
5. The Parties held another fruitful telephonic settlement discussion on February 28, 2012 without Judge Mahoney.
6. In light of the on-going and fruitful settlement discussions, the undersigned counsel believes that it is more important to devote his time to settlement matters rather than to further briefing on the Motion to Dismiss.

WHEREFORE, Respondent Cameel Halim respectfully requests that he be allowed to withdraw, without prejudice, his Motion to Dismiss for Want of Subject-Matter Jurisdiction.
