Dear Mr. Hess:

On July 26, 2012, the U.S. Environmental Protection Agency (EPA) issued an Administrative Order (Order) ordering Hoback Stores, as owner and/or operator of the Hoback Stores public water system, to comply with the Safe Drinking Water Act (SDWA), 42 U.S.C. Section 300f et seq., and its implementing regulations, the National Primary Drinking Water Regulations (NPDWRs), 40 C.F.R. part 141.

Our records indicate that Hoback Stores (Respondent) is again in violation of the Order. Among other things, the Order included the following requirement (summarized from item 14 on page 2 of the Order):

Respondent shall monitor the System's water quarterly for total coliform bacteria as required by 40 § C.F.R. 141.21. Respondent shall report any violation of coliform monitoring requirements in 40 C.F.R. part 141 to the EPA within 10 days after discovering the violation, as required by 40 C.F.R. § 141.21(g)(2).

The EPA did not receive a 4th quarter 2014 total coliform monitoring result. Respondent did not report the total coliform monitoring violation to the EPA.

EPA is considering additional enforcement action as a result of the Respondent's non-compliance with the Order. Violating an Administrative Order may lead to (1) a penalty of up to \$37,500 per day per violation of the Order, and/or (2) a court injunction ordering compliance.
