

ORDER ON SECOND REQUEST FOR EXTENSION OF TIME TO FILE EXECUTED  
 CONSENT AGREEMENT AND FINAL ORDER

On May 20, 2011, the undersigned received an Informative Motion Regarding Progress Made in Filing an Executed Consent Agreement and Final Order and Second Request for Extension of Time to File ("Request") in which Complainant states that the parties have made progress in obtaining approval for a Supplemental Environmental Project ("SEP") as part of the Consent Agreement and Final Order ("CAFO"). Again citing the complexity of the review and concurrence process within the EPA, Complainant requests twenty (20) days to finalize and execute a CAFO. Complainant states that Respondent agrees in the filing of this Request.

Given the progress of the parties in reaching a settlement and fashioning a SEP, the Request is hereby **GRANTED** for good cause shown. However, considering the CAFO has not yet been submitted into concurrence, 20 days seems unrealistic. The parties shall file a CAFO on or before **June 30, 2011**.
