5.2 All of the mechanized landclearing and logging of the wetlands in the mixed wetlands/uplands portion of the west side of the site and the excavation and redeposition of vegetation and topsoil along the east side of the site was not caused by Respondent, nor under his direction, but rather was the sole act of Logger and Contractor Ron Wohl of 6266 Ocean Beach Highway, Longview, WA, or his employees, working for his own interest to acquire up to 80% of the value of the logs and to create developable land along the east side of the site for his own benefit.

6.1 Pursuant to Section 309(g) of the Act, 33 U.S.C. Sections 1319(g), requests a hearing contesting every material fact contained in the Complaint and contesting the appropriatness of the proposed penalty requested.
