
**ORDER ON COMPLAINANT'S MOTION FOR EXTENSION OF
PREHEARING ORDER DEADLINES**

The Prehearing Order issued in this proceeding set filing deadlines for the parties to submit their respective prehearing exchanges and to submit a report on the status of settlement negotiations. The due date for Complainant's prehearing exchange is October 17, 2014. Complainant filed a Motion for Extension of Prehearing Order Deadlines on October 10, 2014, requesting an additional 45 days for each party to file their prehearing exchanges. Grounds stated in the Motion are Complainant's inability to file the Consent Agreement and Final Order, signed by Respondent, due to the ongoing 30 day public comment period for the Administrative Complaint, which expires November 9, 2014. Complainant expects to be able to file the Consent Agreement and Final Order shortly after the public comment period ends. The Motion notes that Respondent has already paid the agreed penalty to Complainant and that Respondent's counsel joins in this request.

The Rules of Practice governing this proceeding, 40 C.F.R. Part 22, provide at 40 C.F.R. § 22.7(b) that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties." Given the status of settlement in this matter, there is good cause to grant the requested 45 day extensions. Therefore, the Motion is hereby **GRANTED** and the deadlines for the prehearing exchanges are extended as follows:

- Monday, December 1, 2014 Complainant's Initial Prehearing Exchange
- Monday, December 29, 2014 Respondent's Prehearing Exchange
- Monday, January 12, 2015 Complainant's Rebuttal Prehearing Exchange


