ORDER ON INFORMATIVE MOTION

The undersigned's Order of January 20, 2011, required Complainant to file a fully executed Consent Agreement and Final Order (CAFO) in this matter by February 19, 2011. On February 14, 2011, Complainant filed an Informative Motion Regarding Progress Made in Filing an Executed Consent Agreement and Final Order and Third Request for Extension of Time to File. The Motion states that some minor modifications are being incorporated to the text of the CAFO and the concurrence process is near completion. The Motion states that the review and concurrence of Region 2's Director of the Division of Enforcement and Compliance Assistance and the signature of the Regional Administrator are pending. Thus, Complainant requests an extension of time until March 18, 2011 to file the fully executed CAFO. The Motion further indicates that the Respondent concurred with the request. Therefore, the Complainant is hereby ORDERED to file the fully executed CAFO memorializing the settlement no later than March 18, 2011, with a copy contemporaneously sent to the undersigned by facsimile and mail.

FAILURE TO SUBMIT THE CONSENT AGREEMENT IN A TIMELY MANNER MAY RESULT IN ENTRY OF AN ORDER OF DISMISSAL WITH PREJUDICE OR DEFAULT, AS APPROPRIATE, WITHOUT FURTHER NOTICE.


