## UNITED STATES ENVIRONMENTAL PROTECTION AGENCY

The United States Environmental Protection Agency (EPA) is authorized under Section 309(g) of the Clean Water Act (CWA), 33 U.S.C. § 1319 (g) to assess civil penalties after providing the persons subject to the penalty notice of the proposed penalty and an opportunity for hearing, and after providing interested persons public notice of the proposed penalties and a reasonable opportunity to comment of their issuance. Under Section 309(g) any person who, without authorization, discharges a pollutant to a navigable water, as those terms are defined in Section 502 of the CWA, 33 U.S.C. § 1362, may be administratively assessed a Class I civil penalty up to a maximum penalty of \$37,500 by EPA. Class I proceedings for Section 309(g) of the CWA are conducted in accordance with the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or Corrective Action Orders, Revocation, Termination of Permits, 64 Fed. Reg. 40138 (July 23, 1999)(Part 22), including Rules related to Administrative Proceedings Not Governed by § 554 of the Administrative Practices Act, 40 C.F.R. §§ 22.50-22.52 (64 Fed. Reg. 40138, 40190).

The procedures by which public may submit written comments on a proposed Class I penalty order are set forth in Part 22. Any person wishing to comment on a proposed penalty order must submit written comments to the Regional Hearing Clerk within thirty (30) days after issuance of this public notice.

Pursuant to Section 309(g)(4) of the CWA, EPA is providing notice of opportunity to comment on the proposed Class I administrative penalty assessment of \$12,150 against The Neenan Company LLLP, regarding its development of the Cambridge Memorial Hospital located at 1305 Highways 6 and 34 in Cambridge, Nebraska. The EPA provides public notice of the proposed assessment pursuant to 33 U.S.C. 1319(g)(4).

In order to provide opportunity for public comment, EPA will issue no final order assessing a penalty in this proceeding prior to forty (40) days from the date of this notice.
