

**AGREED MOTION FOR EXTENSION OF TIME IN WHICH TO FILE  
COMPLAINANT'S INITIAL PREHEARING EXCHANGE**

The Prehearing Order dated October 27, 2011, directs the Complainant to file its Initial Prehearing Exchange on or before December 30, 2011. The parties, however, have reached an agreement in principal and are working to memorialize the agreement in a Consent Agreement and Final Order (CAFO). They expect to finalize the CAFO by February 7, 2012. In order to conserve its resources, Complainant requests that the Administrative Law Judge extend until February 7, 2012, the deadline by which Complainant must file its Initial Prehearing Exchange. Counsel for the respondent has advised counsel for the complainant that he has no objection to this motion and, in fact, is supportive of the motion.
