**ORDER GRANTING MOTION
FOR ADDITIONAL TIME TO FILE CONSENT AGREEMENT**

On December 16, 2009, the Court issued an Order Granting Complainant's Motion for Extension of Time, which "direct[ed] the parties to submit a finalized Consent Agreement and Final Order by February 19, 20[10], or in the alternative, file their initial prehearing exchanges by that date." On February 16, 2010, Complainant submitted a Motion for Additional Time to File Consent Agreement, in which Complainant requests an additional ten (10) days for the parties to file either a finalized Consent Agreement and Final Order or their initial prehearing exchanges. Complainant informs the Court that, as of February 15, 2010, Respondent had executed the consent agreement reached by the parties. However, because Complainant questions its ability to obtain the appropriate signatures within its office by February 19, Complainant seeks an extension of time during which it would "expeditiously endeavor" to obtain the appropriate signatures as soon as Complainant receives a hard copy of the agreement from Respondent. Complainant relates that Respondent joins in its request for an extension.

Upon consideration, the Court grants Complainant's request. Ten days is a reasonable period of time for Complainant to obtain the appropriate signatures. Pursuant to this Order, the Court extends the deadline for the parties to submit either a finalized Consent Agreement and Final Order or their initial prehearing exchanges by ten (10) days, or until March 1, 2010.

So ordered.


