The U.S. Environmental Protection Agency (U.S. EPA) has completed its review of the Supplemental Environmental Project (SEP) Completion Report submitted by Safety-Kleen on September 17, 2020 pursuant to paragraph 66 of the Consent Agreement and Final Order (CAFO). *See In the Matter of Safety-Kleen Systems Inc. (Toledo, Ohio)*, TSCA-05-2019-0016 (Sept. 30, 2019). We have also received

the copy of the check and related documentation provided to Toledo Public Schools (TPS), submitted pursuant to paragraph 70 of the CAFO, to acquire upgraded drinking fountain equipment with point of use filtering systems, as a preventive measure to mitigate the potential for exposure to lead in drinking water. Pursuant to paragraph 67 of the CAFO, this email serves to notify you that U.S. EPA has determined that Safety-Kleen has satisfactorily completed the SEP project and the SEP report.
