ORDER TO SHOW CAUSE

The file before me reflects that Respondent has failed to file either its prehearing exchange or a statement of election only to conduct cross-examination of Complainant's witnesses as its manner of defense on or before July 29, 2008, as required by the Administrative Law Judge's Prehearing Order, dated March 20, 2008, as amended by the undersigned's oral Order Granting the Parties' Joint Motion for Extension of Time, dated April 18, 2008. Complainant timely filed its prehearing exchange.

Under Section 22.17(a) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits, 40 C.F.R. § 22.17(a), a party may be found to be in default upon failure to comply with a prehearing order of the Administrative Law Judge. Therefore, Respondent is ordered to show cause, if any, on or before **August 27, 2008**, why Respondent failed to meet the July 29, 2008, filing deadline and why a default order should not be entered for failing to meet this deadline.
