Bryan Cave represents Kerry Biofunctional Ingredients, Inc. d/b/a Kerry Bio Sciences ("Kerry") in the above-referenced matter. For the reasons set forth below, Kerry respectfully requests an extension of time to answer the Complaint, Compliance Order and Notice of Opportunity for Hearing (the "Complaint") and request a hearing in the above-referenced matter:

- 1. Kerry was served with the Complaint on September 29, 2017.
- 2. On October 25, 2017, Kerry served counsel for EPA, Gary Nurkin, with a request for an informal conference with the Agency.
- 3. On November 14, 2017, Kerry and EPA held an informal settlement conference at EPA Region II during which Kerry presented EPA with a proposal for resolving the matter (the "Kerry Proposal").
- 4. EPA is still evaluating its response to the Kerry Proposal (the "EPA Response") and has not yet been able to finalize the EPA Response for transmittal to Kerry.

- 5. Currently, pursuant to the Regional Judicial Officer's October 31, 2017 Order, an answer is due December 15, 2017.
- 6. In light of the fact that the parties are still working in good faith to achieve settlement but are unlikely to do so before December 15, 2017, undersigned counsel contacted EPA counsel who has, via a December 11, 2017 email, stated that he would not object to Kerry receiving an additional extension until the end of January 2018 in which to answer or otherwise respond to the complaint in this matter.

WHEREFORE, Kerry respectfully requests that Your Honor enter an order granting Kerry an extension of time to answer and/or request a hearing until January 31, 2018.
