Motion Requesting Extension of Time to File CA/FO

COMES NOW Complainant, the U.S. Environmental Protection Agency (“EPA” or “Complainant”) through the undersigned attorney, and respectfully alleges, prays and requests as follows:

1. As stated to this Honorable Court, on May 30, 2012, the Parties finally reached an agreement regarding the language of the CA/FO, and that same day, Respondent signed the CA/FO.
2. However, the extensive process of concurrence, which involves the signature of several persons both in Puerto Rico and New York, has not concluded.
3. Complainant recognizes that it is in the best interest of all the parties involved to file the CA/FO as soon as possible. Therefore, all efforts are being made in order to expedite the concurrence process of the remaining officials.
4. Since the process of concurrence and signature to file a fully executed CA/FO has not been completed, Complainant respectfully requests a final extension until June 21, 2012, to submit the fully executed CA/FO.
5. The granting of seven (7) additional days (until June 21, 2012), to file the duly executed CA/FO will not result in prejudice to Respondent.


