ORDER RESCHEDULING HEARING

On April 18, 2012 the undersigned entered an Order Scheduling Hearing in this matter. Pursuant to that Order, the parties were directed to file a joint set of stipulated facts, exhibits, and testimony by May 25, 2012, and the hearing was scheduled for June 13 and 14, 2012 in Redding, California. On May 8, 2012 Complainant filed a Motion to Postpone Hearing because of a scheduling conflict. Complainant requests that the hearing be rescheduled to June 20 and 21, 2012 and states that Respondents do not oppose the motion to postpone the hearing.

For good cause shown, the hearing will be postponed. The new hearing schedule is as follows. The parties shall file a joint set of stipulated facts, exhibits, and testimony on or before **June 1, 2012**. See Section 22.19(b)(2) of the Rules of Practice, 40 C.F.R. § 22.19(b)(2). The hearing in this matter will be held beginning at 8:30 a.m. on Wednesday, **June 20, 2012, in Redding, California, and continue as necessary through June 21, 2012**. The Hearing Clerk will make appropriate arrangements for a courtroom and retain a stenographic reporter. The parties will be notified of the exact location and other procedures pertinent to the hearing when those arrangements are complete. Individuals requiring special accommodation at this hearing, including wheelchair access, should contact the Hearing Clerk at least ten business days prior to the hearing so that appropriate arrangements can be made.

IF ANY PARTY DOES NOT INTEND TO ATTEND THE HEARING OR HAS GOOD CAUSE FOR NOT BEING ABLE TO ATTEND THE HEARING AS SCHEDULED, IT SHALL NOTIFY THE UNDERSIGNED AT THE EARLIEST POSSIBLE MOMENT.




