JOINT MOTION TO CONTINUE STAY OF THE PROCEEDINGS

Enterprise Terminals and Storage, LLC ("Enterprise Terminals") and Enterprise Products Operating, LLC ("Enterprise Products") (collectively, "Respondents") and the United States Environmental Protection Agency, Region 2 ("EPA") file this Joint Motion to Continue Stay of the Proceedings.

Respondents and EPA (the "Parties") have continued their good faith efforts to resolve this matter in accordance with the framework they previously developed and have made significant progress since their motion filed on September 19, 2012. The Parties have agreed on the terms of a settlement and the language to document the settlement. Respondents anticipate that the officer who will sign on behalf of Respondents will be able to do so next week, the week of November 26, 2012. Therefore, the Parties jointly request that the stay in this matter be extended until December 21, 2012 to allow Respondents time to execute and deliver settlement documentation and to allow EPA time to obtain management signatures. The request for the stay is not for the purpose of delay but to allow the Parties time to execute documentation. The stay would serve the interest of judicial economy.

For the above reasons, the Parties respectfully request that the stay in this matter be continued until December 21, 2012.
