ORDER ON MOTION TO EXTEND TIME TO FILE PREHEARING EXCHANGES

On June 29, 2010, this Tribunal issued a Prehearing Order establishing, inter alia, certain deadlines for the submission of prehearing information from each party. That Order required Complainant to submit its Initial Prehearing Exchange by September 27, 2010.

On September 21, 2010, this Tribunal received Complainant's Motion to Extend Time to File Prehearing Exchanges ("Motion") seeking a two-month extension of the prehearing schedule. In support of its Motion, Complainant states that Respondents' counsel does not object to the extension, that no party would suffer any prejudice, and that "the case stands literally on the threshold of settlement." Mot. at 3. For good cause shown, the Motion is GRANTED.

A Consent Agreement and Final Order ("CAFO"), or Complainant's Initial Prehearing Exchange if no CAFO is filed, shall be due on or before November 29, 2010. Respondent's Prehearing Exchange will then be due December 29, 2010, and Complainant's Rebuttal Prehearing Exchange will be due January 12, 2010.


