The parties in the above-styled case hereby jointly report, consistent with discussions with the Court's law clerk, that they have agreed to finalize the parties' settlement in principle in accordance with the following process: (1) Respondent Agrimor will withdraw its objection to Complainant's Motion for Leave to File a Second Amended Complaint. Within fourteen (14) days after the issuance of an Order by the Court granting Complainant's Motion, Complainant will file the Second Amended Complaint. The parties also request that the Court allow Respondent a period of 30 days to file an Answer to the Second Amended Complaint.

(2) Within twenty-one (21) days after the Second Amended Complaint is filed, the parties will execute a Consent Agreement and Final Order (CAFO), and Complainant will submit the CAFO to the Regional Judicial Officer for approval. Upon final approval of the CAFO, Complainant will send a copy to the Court. Should the parties encounter any delays or difficulties in meeting this schedule, they will advise the Court. If for any reason the CAFO is not finalized within the timeframe set forth herein, Respondent will file its Answer within 30 days after the Second Amended Complaint is filed.
