Dear Messrs. Day and Wolz:

On August 2, 2007, the US Environmental Protection Agency (EPA) issued an Emergency Administrative Order (the Order), Docket No. SDWA-08-2007-0068, ordering the Sleepy Hollow Homeowners Association, Inc. and Brett Wolz, owner and operator respectively (Respondents) to comply with the Safe Drinking Water Act (the Act), 42 U.S.C. Section 300f <u>et seq</u>., and its implementing regulations, the National Primary Drinking Water Regulations (NPDWR) at 40 C.F.R. Part 141.

Our records indicate that Respondents are in violation of the Order. The Order requires the following:

 After Respondents receive written notification from EPA to discontinue daily total coliform sampling, Respondents shall conduct weekly bacteriological sampling, collecting two samples each week. Respondents shall report weekly total coliform sampling results to EPA by telephone and facsimile immediately upon receiving the laboratory results. Respondents failed to conduct weekly bacteriological sampling for the week of August 13 - 19,2007.

EPA is considering additional enforcement action as a result of the System's noncompliance with the Order. Violating an Order may lead to (1) a penalty of up to \$32,500 per day per violation of the Order, and/or (2) a court injunction ordering Respondents to comply.
