Sutin, Regional Judicial Officer, with the following Joint Settlement Report and Second Request to Extend Time for Filing an Answer to update the Judge on the status of the parties' voluntary settlement efforts in the above-referenced matter and need for additional time to achieve a settlement in lieu of Respondent filing an Answer.

- 1. EPA filed an Administrative Complaint and Opportunity to Request a Hearing against Family Tree Corporation on May 27, 2011, under sections 309(g) and 311b(6)(B)(ii) of the Clean Water Act for alleged violations of the oil pollution prevention regulations set forth at 40 C.F.R. Part 112 at its Pilot Butte facility located in Fremont County, Wyoming. The Complaint proposed a civil administrative penalty.
- Pursuant to the Order Granting Extension of Time to File Answer issued by Judge Sutin on June 27, 2011, Respondent's deadline for filing an Answer in this matter was extended through August 19, 2011.
- The parties have been working informally to resolve the matter outside of litigation.

As a precursor to settlement, Respondent has been working to return the facility to

compliance with the Spill Prevention, Control and Countermeasure (SPCC) regulations.

including addressing the physical SPCC deficiencies and updating the SPCC plan.

On August 5, 2011, Respondent submitted a counter-offer for Complainant's

review.

The parties believe that it is in their best interest to resolve this matter outside of

Inigation.

Subject to the Judge granting the parties' joint second request for an extension of

time for filing an Answer, the parties will either file a fully executed Consent Agreement or

Respondent will file an Answer on or before September 30, 2011.
