- 1. On October 10, 2014, EPA, Region III, issued an Administrative Penalty Complaint and Notice of Opportunity to Request Hearing ("Complaint"), naming Charles County, Maryland, as Respondent ("Respondent"). Said Complaint was received by Respondent on October 17, 2014.
- 2. On October 23, 2014, Respondent contacted EPA, Region III, to discuss an extension of time to submit its Answer and Request for a Hearing, based on the fact that EPA's Charles County Municipal Separate Storm Sewer System Inspection Report ("Inspection Report"), provided to the Respondent and upon which the Complaint is based, was not complete as it did not contain all of its referenced appendices.
- 3. EPA provided the missing appendix, containing approximately 791 pages of information.

- 4. On November 14, 2014, the Regional Judicial Officer granted Respondent sixty (60) days to review this information before filing an Answer and Request for a Hearing.
- 5. The Respondent has recently completed its review of the information contained in the missing appendix.
- 6. The Respondent has now begun settlement discussions with EPA.
- 7. Therefore, in order to amicably resolve this matter, both parties mutually agree that it is in their best interests to extend the date for the Respondent to file its Answer and Request for a Hearing by an additional thirty (30) days, which will run from the date of the approval of this Joint Motion.
- 8. Pursuant to 40 C.F.R. § 22.7(b) extensions of time for filing of any document may be granted upon timely motion of a party to the proceeding for good cause shown.
- 9. EPA, Region III, has authorized the Respondent to represent its support for this Joint Motion on its behalf.

**WHEREFORE**, both parties respectfully request that the Respondent be granted a thirty-day (30) extension of time for the Respondent to file and Answer and Request for a Hearing, in order for the parties to amicably resolve this matter.
