
**ORDER GRANTING MOTION FOR EXTENSION OF TIME**

By Joint Motion dated June 17, 2010, the parties moved for a sixth extension of time to file the Consent Agreement and Final Order (CAFO). The Motion indicates that the parties have approved the CAFO but that it awaits approval of the Regional Administrator's office, and that the parties cannot predict when that office will have opportunity to review and sign the CAFO.

The Motion is hereby, **GRANTED**, as set forth below:

Section 22.7(b) of the Rules of Practice (40 C.F.R. § 22.7(b)) provides that the Presiding Officer may grant an extension of time for filing any document upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties.

Good cause exists for the granting of the Motion in that it is in the interest of the parties and judicial economy for the parties to finalize their settlement of this matter on mutually agreeable terms. In that a hearing in this case has yet to be scheduled, no prejudice will result from a brief delay. Therefore, the parties shall have until **July 2, 2010** to file the fully executed Consent Agreement and Final Order.


