RESPONDENT'S MOTION TO CONTINUE DATE FOR FILING OF ANSWER


The Respondent, CWM Chemical Services, LLC ("CWM"), moves the Regional Judicial Officer ("RJO") for an Order continuing the date for filing its answer from November 29, 2010 to January 14, 2011.

By order dated October 27, 2010, the RJO granted the request of CWM for an extension of the time for CWM to file an answer in the above-captioned matter through November 29, 2010. Since that time, CWM has engaged in constructive dialogue with EPA Region 2 staff and counsel, and on the last conference call CWM and counsel for EPA, Ms. Melva Hayden, agreed that an additional extension would be useful. At the time, there was agreement that CWM would request an additional thirty (30) days, and counsel for EPA authorized CWM to inform the RJO that EPA consented to that request.

CWM has since realized that a thirty-day extension results in the deadline for an answer in the middle of the last week of December, which presents vacation concerns for some participants. As a result, CWM requested of Ms. Hayden that EPA consent to an extended due date for the answer of January 14, 2011. CWM has not yet heard back from Ms. Hayden on whether EPA agrees to the January 14 deadline, but in the interest of time CWM wanted to

submit this request for extension immediately so that it could be timely considered in advance of the current November 29 deadline.
